ABOUT RESCUE ONE MORE

In 2011, while living in Kampala, Uganda, the Lambie family encountered Vanessa, an 11-year-old runaway and survivor of sexual abuse. After fostering her for five years, they adopted Vanessa into their family. In 2021, **Vanessa and her parents, Scott and Saran Lambie, launched Rescue One More** to help other survivors of sexual violence against children (SVAC).

In Uganda, **more than 1 in 3 girls and 1 in 6 boys experience SVAC***. Because resources are limited and the stigma surrounding SVAC is significant, **survivors are often silenced by their communities** and forced to endure in silence.

Rescue One More is on a mission to change this by providing survivors with **safety, justice, and healing** while also working to bring an end to SVAC once and for all.

Using a proven community-driven approach developed over decades by the Children's Advocacy Centers, **Rescue One More brings child protection leaders together** to offer coordinated and streamlined responses to abuse, ensure successful investigations and minimize additional trauma to child survivors.

The approach is implemented through **multidisciplinary teams**, which we refer to as **Community Action Teams (or CATs)**, consisting of local law enforcement officers, probation & social welfare officers, social workers, prosecutors, medical & mental health professionals, local NGO leaders, and church leaders

CAT members meet regularly to conduct case reviews and ensure survivors receive safety, justice, and healing.

Through **Rescue One More Centers**, survivors receive safe shelter, trauma counseling, medical care, case management, discipleship opportunities, resettlement services, and more.

Rescue One More was founded with the belief that **God can transform tragedies into triumphs**, as demonstrated by the story of Joseph in the Bible and summed up in Genesis 50: 20-21.

Through Rescue One More, we've seen God's goodness. We hope you've seen it too.

2022 GOALS & STRATEGIES



1

Facilitate safety, justice, and/or healing for 100 children

With our first full year of operations taking place in 2022, our goal of serving 100 children was somewhat arbitrary, but given the scope of the problem, it seemed realistic. We aimed to achieve this goal by:

1. Establishing two additional Community Action Teams in two new districts
2. Establishing our own safe house
3. Establishing a new Rescue One More Center in Mukono District

2

Increase awareness of the issue of SVAC in Uganda

Prevention begins with awareness and education. We began focusing on prevention by:

1. Mobilizing Community Action Teams and partner organizations to hold sensitization and awareness outreaches for community leaders, children (in schools), teachers, parents, and the community at large
2. Launching a national media campaign in Uganda

3

Expand team in Uganda and register with government

Establishing credibility and trust among government actors, potential partners, donors, and other agencies requires rigorous monitoring and evaluation practices as well as transparent operations. The first steps to achieving this included:

1. Hiring staff members to work with, monitor, and track partner activities
2. Registering for CBO (community-based organization) status in Uganda

4

Increase local (US) awareness and expand donor base

While all of our operations take place in Uganda, most of our donors reside within North America. We aimed to increase awareness in the states by:

1. Solidifying financial partnerships with five additional US-based churches
2. Focusing on generating greater awareness specifically within Dripping Springs and the Central Texas region

2022 OUTCOMES

In Uganda:

- Hired **2 full-time social workers**
- Retained legal representation in Uganda and began applying for **Non-Governmental Organization (NGO) status** (rather than CBO status)
- Secured **implementation partnership** with Cornerstone Development Africa
- Secured **media coverage** on 6 national news programs
- Secured commitments from **200 local government leaders** to fight child sexual violence in Mukono and Wakiso districts
- **Reached 30,000+ people** with awareness and prevention messages

In the U.S.:

- Received final determination letter and **full 501c3** designation
- Solidified **financial relationships with two new churches** in 2022, bringing the total number of US-based church partners to seven
- Established a **board of directors**
- Awarded **Gold Transparency Seal** from Candid (formerly GuideStar)
- Hosted **2 donor events**
- **Spoke at 4 churches** and 1 event

Fundraising:

Raised \$368,204 in donations:

- 201 individual donors (adding 119 over 2021)
- 38 monthly donors (adding 20 over 2021)
- 7 church donors (adding 2 over 2021)

MEET KATY*

The first time 12-year-old Katy was raped by her father, he told her he'd kill her and her mother if she told anyone.

The second time, Katy fought back. He beat her severely for resisting him.

When Katy's mother found her daughter injured, she immediately reported the incident to police. But, pressured by her husband, she decided to drop the charges. How would she pay rent and take care of her family with her husband, the local traditional healer, behind bars?

Fortunately, the police officer, who sits on the Mukono Community Action Team (CAT), was there. He helped Katy's mother understand the law along with the risk her husband would pose to both her

daughter and other children in the community.

The CAT referred Katy to Petros Zoe Initiative, a Mukono-based NGO and Rescue One More Partner, for safe shelter, trauma counseling, medical care, and legal services.

Today, Katy says she feels safe again. More importantly, she has hope for her future.

She recently started attending a new primary school thanks to the sponsorship of a member of the Mukono CAT.

The team continues to monitoring her case to ensure her father remains in jail and Katy continues to receive the physical, emotional, and spiritual support she needs to live a happy, healthy, and fruitful life.

MEET MARY*

4-year-old Mary was playing with friends in a fishing village when a man she recognized invited her to have a soda with him.

The man lured her into a bar where he drank as she enjoyed her soda. At some point, he took her into the forest and raped her.

Mary had been missing for hours when her older sister finally found her. She was covered in dirt and blood. She took Mary home, bathed her, and washed her clothes. Her mother then took her to a medical clinic for treatment and reported the incident to police.

When the Mukono Community Action Team (CAT) learned of Mary's case, they coordinated the

investigation and response effort, with local law enforcement, child protection officers, a prosecutor, and Petros Zoe Initiative, a Mukono-based NGO that partners with Rescue One More.

Within a few weeks, the perpetrator was arrested. But Mary was so traumatized by the event she could hardly eat, speak, or sleep. Her mother was distraught as well.

The CAT responded again by providing both Mary and her mother with psychosocial support, trauma counseling, and other measures to ensure Mary's safety.

Today, Mary is eating, talking, and sleeping normally again.
